As used in this document, "Dance Activity" means any dance performance, dance practice, classes, warm-ups or related activity associated with instruction, supervision, assistance, and/or choreography by Rogue Co. Dance Company or any person employed by them.

I/we agree to release and hold harmless the dance studio or facility or proprietor of space utilized from any cause of action, claims, or demands now and in the future for any personal injury or any personal property damage, which may occur on the premises before, during or after any Dance Activity connected with Rogue Co. Dance Company. I/we agree to obey all the studio/facility/space rules and take full responsibility for my/our behavior in addition to any damage I/we may cause.

By submitting this form, I/we give consent for my/our child or ward to be photographed and/or videotaped during or before or after any Dance Activity. I/we also give consent for these photos and/or videos to be used by Rogue Co. Dance Company at their sole discretion for promotion and display.
